Pursuant to Article 22 of the Law on the Government of Brčko District BiH ("Official Gazette of Brčko District BiH", number: 22/18 - revised text, 49/18, 8/19, 10/19 and 32/19), Article 187 of the Law on Administrative Procedure of Brčko District BiH ("Official Gazette of Brčko District BiH", number: 48/11 - revised text, 21/18 and 23/19), Article 2, Paragraph (7) of the Law on Higher Education in the Brčko District of BiH ("Official Gazette of the Brčko District of BiH", number: 30/09, 29/18, 16/20 and 44/22), and in accordance with Article 4, Paragraph (2) of the Rulebook on the content, registration procedure and method of keeping the register of higher-educational institutions in the territory of Brčko District BiH ("Official Gazette of Brčko District BiH", number: 29/21), the Department of Education of the Government of Brčko District BiH hereby issues a

DECISION

1. The University "Business Academy" of Brčko District of Bosnia and Herzegovina, address: Brčko District of Bosnia and Herzegovina, Petra Kočića 6, is registered in the Register of Higher-Educational Institutions in Brčko District of Bosnia and Herzegovina, under number 9.
2. The Department of Education of the Government of Brčko District of Bosnia and Herzegovina, Sub-Department for Higher Education and Science is responsible for the execution of the decision from Clause 1 of the enacting clause of this decision.

EXPLANATION

In accordance with Article 4, Paragraph (3) of the Rulebook on the content, registration procedure and the method of keeping the register of higher-educational institutions in Brčko District BiH ("Official Gazette of Brčko District BiH", number: 29/21), the head of the Department of Education appointed the Commission that examines the conditions for the admission of the University "Business Academy" of Brčko District of Bosnia and Herzegovina to the Register of higher-educational institutions by Decision file number: 05-000123/23, document number: 07-1246ZB-001/23 dated 8 February 2023. The Commission reviewed the Decision on the issuance of a license for the higher-educational institution to the University "Business Academy" of Brčko District BiH, file number: UP-I-37-000232/21, document number: 07-1246ZB-025/23 dated 7 February 2023, as well as the legal acts and by-laws that regulate the above-mentioned matter and made the Report, file number: 05-000123/23, document number: 07-1334AM-001/23 dated 9 February 2023, and delivered the same to the head of the Department within the time limit prescribed by the Rulebook on the content,



registration procedure and method of keeping the register of higher-educational institutions in the area of Brčko District BiH.

Upon inspection of the aforementioned Decision, legal acts and by-laws, it was determined that the Department of Education issued a Decision on the issuance of a license for higher-educational institution to the University "Business Academy" of Brčko District BiH file number: UP-I-37-000232/21, document number: 07-1246ZB-025/23 dated 7 February 2023 based on the law and other regulations as well as the Licensing Commission's Report dated 31 January 2023.

In accordance with Article 29, Paragraph (7) of the Law on Higher Education in Brčko District BiH, it is stipulated that after obtaining the license from Paragraph 6 of this Article, the Department registers the higher-educational institution in the Register of higher-educational institutions. In its Report, file number: 05-000123/23, document number: 07-1334AM-001/23 dated 9 February 2023, the Commission concluded that all the legal requirements for the registration of the higher-educational institution University "Business Academy" of Brčko District of Bosnia and Herzegovina in the Register of higher-education institutions in the area of Brčko District of Bosnia and Herzegovina have been met and made a proposal to the head of the Department to enter the University "Business Academy" of Brčko District of Bosnia and Herzegovina in the Register of higher-education institutions in the area of Brčko District BiH, based on the adoption of the Decision on the entry of said higher-educational institution in the Register.

Article 4, Paragraph (1) of the Rulebook on the content, registration procedure and method of keeping the register of higher-educational institutions in the area of Brčko District BiH ("Official Gazette of Brčko District BiH", number: 29/21) stipulates that the Department of Education ex officio registers a higher-educational institution in the Register after issuing a license from Article 29 of the Law on Higher Education in Brčko District BiH.

In accordance with all the above, it was decided as in the enacting clause of this Decision.

Legal remedy:

An appeal against this Decision can be lodged with the Appeals Commission of Brčko District BiH within 15 days from the date of delivery and is submitted through the Department of Education.
